Franklin-Wright Settlement Services College Tour Participant Agreement 2018

- ❖ Fighting, abusive or foul language, inappropriate touching or racial teasing is not allowed and will not be tolerated.
- ❖ Disrespectful acts will not be tolerated. Such acts will be subject to suspension and/or expulsion depending on the severity.
- ❖ Youth will not be allowed to leave the site with anyone (including family members) unless chaperones have received previously obtained special permission from parents.
- ❖ Safety rules will be enforced to prevent accidents or injuries. Engaging in any activity that could endanger the health and safety of you, your peers and others will not be permitted.
- ❖ Drugs or alcohol will not be allowed. Anyone under the influence of alcohol or drugs will not be permitted to remain on the trip and the police will be called to assume custody.
- ❖ Franklin-Wright Settlements will not be responsible for lost, stolen or damaged items.
- ❖ No fireworks will be permitted on trip.
- ❖ No types of weapons (including water guns) will be allowed. Violation of this rule will result in immediate expulsion.
- ❖ Youth must abide by the dress code designated for the trip.
- ❖ Youth must attend the scheduled tours daily. During the tours, cell phones must be turned off, students must take notes, and questions for the university staff are encouraged.

College Tour 2018 Dress Code

- Skirts, shorts, and dresses cannot be any more than 3 inches above the knee
- All pants, shorts, skirts, capris, etc. must be worn on the waist line.
- No midriff shirts- all shirts must go below the waist line and completely cover the chest
- No hats/caps/do-rags/bandanas while indoors
- Inappropriate lettering and/or illustrations on clothing are prohibited
- No pajamas pants/sleepwear are to be worn outside of the hotel
- Strapless tops must be accompanied with tank tops or camisoles
- No tank tops or camisoles should be worn without another top to reduce exposure
